

2009 Snyder's "Orlando Vacation" Sweepstakes Official Rules

No Purchase Necessary. Sweepstakes begins at 3:00 p.m. Central Daylight Time (CDT) on June 1, 2009 and ends at 3:00 p.m. CDT on October 31, 2009 ("Sweepstakes Period"). Sweepstakes open to residents of United States who are 18 years of age or older. Void where prohibited by law.
